




# **Blueberry Season**

# **Abegweit Development Corporation**

Abegweit Development Inc. is the new economic development arm of Abegweit First Nation. The Development Corporation is governed by a board of directors that currently includes:

- Chief Roderick "Junior" Gould Chief of Abegweit First Nation
- Olive Crane Director of Strategic Planning for Abegweit First Nation
- Lee Bragg Vice Chair of Eastlink and its associated companies
- **Doug Newson** CEO of the Charlottetown Airport Authority
- Jauvonne Kitto Owner of the Saa Dene Group of Companies

Abegweit Development Inc. was established to lead the economic development and equity investment strategy for the Band. Its primary objectives are to build community wealth, promote financial independence, and enhance economic sovereignty. The Corporation achieves this through the development and oversight of strategic investments in new partnerships and diverse business ventures that create jobs, generate revenue, and contribute to the overall well-being of the community.

# **Lands Update**

Starting in September 2024, Courtney Sark was hired to create a Land Use Plan for Abegweit. Since that time, she has been doing community engagement, as well as research into land plans created by Bands across the country.

The Land Plan for Abegweit will be a living document, meaning it can be amended if anything changes, or more band land is purchased, and will also be fully updated every 5-10 years. The plan contains policies for how band land will be used i.e. Residential, agricultural, recreational, spiritual/cultural, industrial, and commercial. Courtney is still taking comments from the community, and can be send via email to csark@abegweit.ca

After completion of the Land Plan, Courtney will be switching gears to continue work on the Land Code. A Land Code is a legal framework developed by a First Nation to manage their reserve lands and resources independently, taking the First Nation out of 44 sections of the Indian Act under land management. This gives a Band more jurisdiction over their lands and will no longer have to ask government permission when using reserve land.

The Land Code requires a vote by Band members, so Courtney will be doing community engagement through out the Land Code process to make sure everyone is informed and will be able to answer any questions!

After 25 years of hard work the Band has finally got the Hillsborough River marked for safe navigation! Big thank you to Shad Qadri -Design and Review Specialist, Aids to Navigation and Waterways, Canadian Coast Guard with the Department of Fisheries and Oceans Canada - who met with the team and helped to get the work done.
